We started 2019 with four opportunities in mind. It's incredible to look back at how the Spirit led us to reach our goals. We are more fully engaged in adult ministry through Discover Your Spiritual Gifts and new groups addressing Grandparenting Support, Veterans Support, Cancer Awareness, and Creation Care. Our senior ministry is thriving, capped off with a hilarious evening in December when we welcomed a comedic troop called the Looney Lutherans. Camp grants inspired 16 kids to super-charge their Faith last summer. Our 10:30 worship service is engaging. Nate Bergengren, our new Modern Worship Director, complements to



our talented musicians and his leadership with a deep Lutheran theology brings out another voice in our worship services.





All this is happening in addition to continued excellence in so many areas! We had 26 students affirm their


TOTAL EXPENSES


